New York, NY – On Thursday, May 11th, 2023, Community Access hosted its 49th Annual Good Neighbor Gala, a fundraiser and celebration to raise support for the nonprofit's critical work in ending homelessness by providing life-saving services to individuals and families across New York City, including supportive housing, hot meals, mental health care, and more. The event was held at 583 Park Avenue in Manhattan, with more than 500 leaders of business and the community attending.

Gala leadership included Gala Chair Emmy-Award winning actor and director John Turturro, Gala Chair Dan Wurtzel, President of FirstService Residential New York, and Gala Chair Ricki Lake, Emmy-Award Winner, Actor, and Host. Ashley Judd, mental health advocate, activist, and actress, appeared as a special guest speaker.

ESKW/Architects and Richman Housing Resources were honored as Community Access' Affordable Housing Advocates of the Year for their commitment to community development and affordable housing. The two organizations have been a central force in designing, developing, and funding buildings for people living with mental health concerns and families with children coming out of the shelter system for decades.
